

**THE REGULAR MEETING OF THE
SHERWOOD IMPROVEMENT DISTRICT
September 13, 2022**

The regular meeting of the Sherwood Improvement District was held on Tuesday, September 13, 2022, at 6910 SW Fountaindale Road, Topeka, Kansas. Board members present were George Schuler, Rick Nesbitt, and Doug Mays.

Also attending were Kevin Holland (Cook, Flatt & Strobel, PA), Lt. Tony De Jesus (Reserves Division of the Shawnee County Sheriff's Office), James Crowl (Shawnee County Counselor), Kelsey Culver.

George Schuler opened the Revenue Neutral Rate hearing and called for comments or questions from those present. No questions were asked. Rick moved to close the RNR Hearing. The motion was seconded and carried. The hearing was closed.

George Schuler moved to open the budget hearing for the Sherwood Improvement District. The motion was seconded and carried. No questions or comments were heard. Rick moved to accept the 2023 budget as published with the understanding the Sherwood Improvement District would exceed the Revenue Neutral Rate of 7.788. Two votes to pass the budget: George Schuler and Rick Nesbitt. One vote to deny the 2023 budget: Doug Mays. Budget passed for 2023. The motion was seconded and carried. George made a motion to close the 2023 Budget Hearing. Motion was seconded and carried.

George Schuler called the meeting to order.

Lt. DeJesus briefed everyone on the happenings for the prior month.

George Schuler asked for motions to approve the regular meeting minutes for the month of August 2022. The motion was made by George and seconded by Doug.
